- <u>All utilities:</u> This certificate does <u>not</u> authorize the connection of utility service to any land located within the subdivision that has been further subdivided or may be required to be replatted by the provisions of the Model Subdivision Rules, Local Government Code or other conditions imposed by either the local government or public utility service provider that restricts the connection of utilities (i.e., floodplain, service agreements, etc.).
- Water service: Authorization to connect is limited to <u>only</u> those specific lots depicted on the recorded plat described herein <u>and</u> must provide for the connection to all residential structures located on the property.
- **Sewer service**: Authorization to connect is limited to <u>only</u> those specific lots depicted on the recorded plat described herein <u>and</u> must provide for the connection to <u>all residential structures and sewage disposal systems</u> located on the property.
- <u>Electrical & gas service</u>: Authorization to connect is limited to <u>only</u> those specific lots in which water and sewer services have been installed and are fully operable for <u>all residential structures and all sewage disposal systems</u> located on the property.
