AGREEMENT BY AND BETWEEN THE WEBB COUNTY COMMUNITY ACTION AGENCY AND TRIUMPH MECHANICAL INC.

Webb County Community Action Agency and Triumph Mechanical Inc., 1717 Plum Street Laredo, Texas 78043, enter into this Agreement effective July 11, 2016 and terminates on December 31, 2016.

1. Scope of Services

Triumph Mechanical Inc. agrees to provide repair, replace, or retrofit of HVAC Systems, window units and electric room space heaters in eligible low-income dwellings throughout Webb County, Texas. These services are delivered pursuant to the Comprehensive Energy Assistance Program (CEAP), crisis heating and cooling component following the International Residential Code or City Code whichever is the most restrictive and are designed to resolve heating and cooling health hazards.

Service Provider shall submit to Webb County Community Action Agency a HVAC System, window units and/or electric room space heaters assessment for approval before repairing, replacing, or retrofit of HVAC System, window units and/or electric room space heaters. Assessment should include a summary of observations, diagnostic methodology, diagnostic finding, recommendations, and cost estimation.

2. Payment Policy Pursuant To This Agreement:

Service and repair of existing heating and cooling units may not to exceed \$2,500 per dwelling. All charges shall be according to submission to Bid No. 2016-11 CEAP Heating and Cooling Service Provider (see Exhibit A). Documentation of service/repair, photographs of heating and cooling units, and related warranty must be included with invoice. Payments are rendered within 45 working days after submission of documentation.

NOTE: "Any holder of this consumer credit contract is subject to all the claims and defenses which the debtor could assert against the seller of goods or services obtained pursuant hereto or with the proceeds hereof. Recovery hereunder by the debtor shall not exceed the amount paid by the debtor hereunder."

4. Relationship of Parties:

Triumph Mechanical Inc., in providing the Services, is acting as an independent contractor and does not undertake by this Agreement or otherwise to perform any regulatory or contractual obligation of Webb County Community Action Agency. Triumph Mechanical Inc. has the sole right and obligation to supervise, manage, contract, direct, procure, perform, or cause to be performed all work to be performed by the company under this Agreement.

5. Texas Administrative Code:

Chapter 5 - Conflict of Interest:

Webb County Community Action Agency. Employees, executive directors, officers, and/or agents shall neither solicit nor accept gratuities, favors, or anything of monetary value from Triumph Mechanical Inc. Any alterations, additions, or deletions to the terms of the contract which are required by changes in federal law and regulations or state statute are automatically incorporated into the contract without written amendment, and shall become effective on the date designated by such law and or regulations; and any other alterations, addition, or deletion to the terms of the contract shall be amended hereto in writing and executed by both parties to the contract.

6. Entire Agreement:

This Agreement sets forth the entire understanding and agreement of the parties and supersedes any and all oral or written agreements or understandings between the parties as to the subject matter of this Agreement. It may be changed only by a writing signed by both parties. Neither party is relying upon any warranties, representations, assurances or inducements not expressly set forth herein.

7. Indemnity:

Triumph Mechanical Inc. shall defend, indemnify and hold Webb County and the Webb County Community Action Agency harmless from any and all loss, expense, cost or liability (including reasonable legal fees and expenses), arising from any claim or cause of action for any loss or damage caused by or arising from the performance of Triumph Mechanical Inc.'s obligations under this agreement, including, but not limited to, the conduct of Triumph Mechanical Inc.'s employees and/or any acts performed under this contract and that result from any negligent act, error or omission of Triumph Mechanical Inc. or of any person employed by Triumph Mechanical Inc. In case of any such claim, Triumph Mechanical Inc., upon notice from Webb County and/or Webb County Community Action Agency, covenants to defend any such action or proceeding. Triumph Mechanical Inc., shall also save and hold harmless Webb County and/or Webb County Community Action Agency, form and against any and all expenses, court costs, including but not limited to attorney's fees that might be incurred, in litigation or otherwise defending or prosecuting claims.

8. Governing Law:

This Agreement shall be governed and construed and interpreted in accordance with the laws of the State of Texas, without regard to choice of law rules of any jurisdiction. The parties agree venue lies exclusively in Webb County.
