KNOW ALL MEN BY THESE PRESENTS:

That this agreement made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2017, by and between the Owner, Webb County, and **BRENNTAG SOUTHWEST INC.**, hereinafter called the "Contractor."

**WITNESSETH:** That said parties have agreed as set forth below:


1. That the Contractor hereby contracts with the Owner in connection with the project to do the following work and services required by the Owner and detailed by this document or other attachments providing description of services to be provided.
2. That the work herein contemplated shall consist of the Contractor furnishing, as an independent contractor, all labor, tools, appliances and materials necessary for the completion of said project in accordance with the specifications and pricing agreements hereto attached and made a part of this contract the same as if written herein.
3. The Contractor hereby agrees and binds himself to commence work within ten (10) days after notification or "Notice to Proceed" issued by Webb County.
4. The Owner shall pay the Contractor for the performance of the work, subject to additions and deductions by Change Order, the contract price established under this agreement.
5. Based upon request for payment submitted to the Utilities Department, the Owner shall make project completion payments on account of the approved sum to the contract as follows:  
They will be due and payable on Contract, approximately each thirty (30) days, an amount equal to 100% of the value of the work completed.

- 6. The Contractor agrees to fully indemnify and save whole and harmless the County of Webb from all costs or damages arising out of any real or asserted claim or cause of action against it of whatsoever kind or character and in addition, from any and all costs or damages arising out of any wrongs, injuries, demands or suits for damages, either real or asserted, claimed against it that may be occasioned by any act, omission, neglect or misconduct of the said Contractor, his agents, servants, and employees.
- 7. The Contract Documents consist of this agreement, contractor's responses to proposal and any exhibits attached hereto, conditions of the contract (special, supplementary and other conditions), specifications, all addenda issued prior to execution of this agreement and all modifications issued subsequent thereto. These form the contract, and all are as fully a part of the contract as if attached to this agreement or repeated herein.
- 8. This agreement shall terminate On September 30<sup>th</sup>, 2017.




