**RESOLUTION AND ORDER OF THE  
WEBB COUNTY COMMISSIONERS COURT**

**TO NOMINATE A CANDIDATE AND TO CAST ITS VOTES  
FOR THE COUNTY'S NOMINEE TO THE WEBB COUNTY  
APPRAISAL DISTRICT BOARD OF DIRECTORS**

**WHEREAS**, Webb County is taxing unit which participates in the Webb County Appraisal District;

**WHEREAS**, Webb County Appraisal District is governed by five directors selected by the taxing units which participate in the Webb County Appraisal District; and

**WHEREAS**, the Webb County Commissioners Court has taken official action per Section 6.033 of the Texas Property Tax Code to call for the recall of the County's member and to cast its 956 votes in favor of the recall of the County's member on the Webb County Appraisal District Board of Directors; and

**WHEREAS**, a majority of the votes cast for the director's position were also cast in favor of the recall of the County's member, Frank Sciaraffa, on the Webb County Appraisal District Board of Directors; and


**WHEREAS**, the official action will be files with the Chief Appraiser for the Webb County Appraisal District and cause the Webb County Commissioners Court's member to be recall; and

**WHEREAS**, the Texas Property Tax Code establishes that Webb County may nominate a candidate to replace the recalled County member and may cast its votes to elect a new member to the Webb County Appraisal District Board of Directors;

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE WEBB  
COUNTY COMMISSIONERS COURT THAT:**

1. The Webb County Commissioners Court nominates Jesse Gonzalez as its candidate to serve on the Webb County Appraisal District Board of Directors.
2. The Webb County Commissioners Court casts its 956 votes for Jesse Gonzalez to serve as the County's new member on the Webb County Appraisal District Board of Directors for the remainder of the 2016-2017 term.
3. This resolution be filed with Martin Villarreal, Chief Appraiser, Webb County Appraisal District, in accordance with the requirements of Section 6.033 of the Texas Property Tax Code.
