



Webb County Commissioners Court Order Order Adopting the Property Tax Rate For Fiscal Year 2018-2019

On this the 10th of September 2018, came to be considered the property tax rate for fiscal year 2018-2019, and it appearing to the Webb County Commissioners Court that said property tax rate has been duly calculated in accordance with applicable law, and all required public notices fully files, and the said property tax rate having been duly considered by the Commissioners Court, it is ordered by the Webb County Commissioners Court that the said property tax rate be hereby levied under the provisions of Article VIII, Section 9(a) and 9(b), Texas Constitution and Section 26.05 Tax Code and approved and adopted as follows:

ORDER

The total Maintenance and Operation rate shall be \$0.376229 per \$100 valuation of which \$0.360645 will be for the General Fund and \$0.018284 will be for the Road & Bridge Fund.

The total Debt Service rate shall be \$0.035771 per \$100 valuation of which \$0.034501 will be for the General Fund debt and \$0.001270 will be for the Road & Bridge debt.

The Total Property Tax rate shall be \$0.412000 per \$100 valuation. THIS PROPERTY TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE & OPERATIONS THAN LAST YEAR'S PROPERTY TAX RATE.

No Tax is levied under Article VIII, Section 9(c) Texas Constitution. Pursuant to Article VIII, Section 9(d) Texas Constitution, the County may put all tax money collected by the County into one General Fund, without regard to the purpose or source of each tax.
