SUPPORTING THE UNIVERSITY OF TEXAS (UT) HEALTH SAN ANTONIO REGIONAL CAMPUS AT LAREDO AND REQUESTING THE STATE LEGISLATURE RESTORE AND SUSTAIN FUNDING FOR THE UNIVERSITY OF TEXAS (UT) HEALTH SAN ANTONIO REGIONAL CAMPUS AT LAREDO

WHEREAS, Webb County, Texas has always had a shortage of well-trained health-care professionals; and

WHEREAS, Webb County, Texas' rapid population growth has exacerbated the need for health-care professionals available to serve the community; and

WHEREAS, Webb County has a poverty rate of 32.1%, one of the highest in the State of Texas; and

WHEREAS, Webb County is in dire need of well-trained health-care professionals; and,

WHEREAS, Webb County's geographic location, being distant from institutions offering advanced health-professional training programs, presents a challenge to local students who cannot travel to obtain an education; and,

WHEREAS, Webb County is medically underserved; and

WHEREAS, the population demographics and location of Webb County, Texas ensure it shall remain a highly bilingual and bicultural community; and,

WHEREAS, The University of Texas (UT) Health San Antonio Regional Campus at Laredo, by providing advanced training to future health-care professionals and educational outreach to the community, has helped ameliorate the effects of insufficient health care professionals and has served and benefited the residents of Webb County, Texas.


NOW THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONERS COURT THAT IT:

Section 1: Supports the UT Health San Antonio Regional Campus at Laredo.


Section 2: Requests the Texas Legislature restore and sustain funding for the UT Health San Antonio Regional Campus at Laredo.
