**Third Party Funding Agreement  
By and Between  
Webb County, Texas  
and  
Special Olympics Texas - Area 21 Laredo**

This agreement is made and entered into by and between the County of Webb, a political subdivision of the State of Texas, acting herein by and through its County Judge, as authorized by its Commissioners Court, (hereinafter referred to as "County") and the **Special Olympics Texas - Area 21 Laredo**, a non-profit corporation, acting by and through Mr. Tim Martin its Executive Director.

The parties do agree and contract as follows:

**ARTICLE 1  
SCOPE OF SERVICES**

Special Olympics Texas - Area 21 Laredo, covenants and agrees to provide the services set forth in the attached Exhibit "A" incorporated herein by reference as if set out in full during Webb County's fiscal year, being October 1, 2020 through September 30, 2021.

**ARTICLE 2  
PERSONNEL AND EQUIPMENT**

Special Olympics Texas - Area 21 Laredo, agrees to furnish all personnel with the required skills and expertise needed to perform the above-mentioned services at no additional cost to the County other than as provided in Article 5. In addition, Special Olympics Texas - Area 21 Laredo, shall provide all necessary equipment, supplies, vehicles, utilities and miscellaneous expenses incurred in performing the scope of services at no additional cost to the County other than as provided in Article 5.

**ARTICLE 3  
REPORT TO COUNTY**

Special Olympics Texas - Area 21 Laredo, shall submit a detailed annual report to the **County Auditor** with copy of same to the **County Treasurer**, which shall identify the services delivered and expenses incurred under this agreement. Said report shall be submitted to the County no later than September 30, 2021.

**ARTICLE 4  
DURATION OF CONTRACT**

This agreement shall be in effect for 12 months beginning October 1, 2020 and ending September 30, 2021.

**ARTICLE 5  
COMPENSATION**

County shall fund Special Olympics Texas - Area 21 Laredo, a total of TEN THOUSAND DOLLARS (\$10,000.00) for its services under this agreement, payable within fifteen (15) days of the Commissioners Court approval of this contract.

It is expressly understood and agreed by the parties hereto that the TEN THOUSAND DOLLARS (\$10,000.00) is subject to the availability of funds. This TEN THOUSAND DOLLARS (\$10,000.00) is the total maximum sum specifically allocated to fully discharge any and all liabilities that may be incurred by County under the provisions of this Agreement, regardless of the nature and notwithstanding any word, statement, or thing contained or inferred from the provisions of this Agreement, which might in any light by any person be interpreted to the contrary. It is expressly agreed that **absolutely none of the funds granted by this agreement shall be used for any payroll expenses, employee wages, benefits and or salaries** and failure to comply with this provision is a material breach of this contract and may obligate Special Olympics Texas - Area 21 Laredo to repay funds and/or disqualify Special Olympics Texas - Area 21 Laredo from applying for this grant in the future.

**ARTICLE 6  
NON-ASSIGNABILITY**

Special Olympics Texas - Area 21 Laredo, shall not assign any interest in this agreement nor delegate the performance of any of its duties herein specified without the written consent of County.

**ARTICLE 7  
ACCESS BY COUNTY TO RECORDS**

Special Olympics Texas - Area 21 Laredo expressly agrees to maintain complete and accurate financial records of expenditures made by Special Olympics Texas - Area 21 Laredo and as requested by the Commissioner's Court, the County Auditor, or their designee, shall make the records available to the Commissioners Court, County Auditor or their designees, for inspection and review. Additionally, Special Olympics Texas - Area 21 Laredo shall permit representatives of the County, including but not limited to the County Auditor and independent auditor, access to the names, addresses, services rendered, and all other required documents related to the Special Olympics Texas - Area 21 Laredo performance under this contract. All such required records shall be clearly identified and readily accessible to the County for three (3) years after final payment under this contract, or after termination of this contract, whichever is later.

**ARTICLE 8  
COUNTY'S RIGHT TO TERMINATE**

This contract may be terminated by County at any time on 30 days written notice to Special Olympics Texas - Area 21 Laredo

**ARTICLE 9  
ENTIRE AGREEMENT**

This contract supersedes any and all prior agreements between the County and Special Olympics Texas - Area 21 Laredo whether written or oral.

**ARTICLE 10  
NON-DISCRIMINATION**

Special Olympics Texas - Area 21 Laredo shall not discriminate against any employee or applicant because of race, religion, color, sex, handicap or national origin.

**ARTICLE 11  
INDEMNIFICATION**

Special Olympics Texas - Area 21 Laredo shall indemnify and hold County harmless from any and all claims arising out of the performance of its duties under this agreement.

**ARTICLE 12  
NOTICES**

All notices called for or contemplated hereunder shall be in writing and shall be deemed to have been duly given when personally delivered or forty eight (48) hours after mailed to each party by certified mail, return receipt requested, postage prepaid as follows:

This Agreement may be executed in any number of and by the different parties hereto on separate counterparts, each of which when so executed shall be deemed to be an original, and such counterparts shall together constitute but one and the same document.


**ARTICLE 20  
TERMINOLOGY AND DEFINITIONS**


All personal pronouns used herein, whether used in the masculine, feminine, or neutral, shall include all other genders; the singular shall include the plural and the plural shall include the singular.





Special Olympics provides programming to individuals with intellectual disabilities in the Laredo Area. Programs include sports training and competitions (track and field, bowling, softball, basketball, and soccer). Other programs include MATP (Motor Activities Training Program) and YAP (Young Athletes Program). MATP provides opportunities for athletes with severe physical and/or cognitive limitations to develop motor skills with the emphasis on personal best. In the Young Athletes Program, children ages 2-7 with and without disabilities, build better motor skills, kindergarten readiness skills, and build self confidence. This program also emphasizes personal best rather than competition between athletes.
