This Agreement is made and entered into by and between **WEBB COUNTY, TEXAS**, a Political Subdivision of the State of Texas (hereinafter "Owner") and **R.G. ENTERPRISES, LLC.**, a Texas Limited Liability Company, **D/B/A G&G CONTRACTORS**, , (hereinafter "Contractor").

For and in consideration of the mutual covenants herein set forth, and other good and valuable consideration, the Parties do hereby agree as follows:

WITNESSETH, that the Contractor and Webb County for the considerations stated herein mutually agree as follows:

ARTICLE 1. Statement of Work. The Contractor shall furnish all supervision, technical personnel, labor, materials, machinery, tools, equipment and services, including utility and transportation services, and perform and complete all work required for the construction of the "Mirando City Water Well Project Transmission Main" embraced in the Project; namely, **TX CDBG TCDP CONTRACT NO. 7219095**-Webb County Invitation to Bid "I.T.B. 2021-004 "Mirando City Water Well Transmission Main Construction Project, for the Webb County Community Action Agency CAA/Texas Community Development Block Grant (TxCDBG) project, all in strict accordance with the contract documents including all addenda thereto, numbered n/a, and construction plans, foundation plans, project designs, job specifications and any addendums thereto.

"ARTICLE 2. The Contract Price. Webb County will pay the Contractor for the performance of the Contract, in current funds, subject to additions and deductions as provided in Section 109 hereof, the sum of **THREE HUNDRED THIRTY-SIX THOUSAND, TWELVE AND 80/100 DOLLARS (\$336,012.80).**"

ARTICLE 3. The Contract. The executed contract documents shall consist of the following components:

- b. Addenda n/a
- c. Invitation for Bids (I.T.B.) -**Exhibit "A"**
- c. Instructions to Bidders (see I.T.B.)
- d. Signed Copy of Bid (**Exhibit "B"**)
- e. General Conditions, Part I (**Exhibit "C"**.) (page 4)
- f. Special Conditions (see I.T.B)
- h. Technical Specifications (I.T.B.)
- i. Drawings (**Exhibit "D"**)
- j. **Additional Exhibits see pages 29 & 30.**

ARTICLE 4. Performance. Work, in accordance with the Contract dated January 25, 2021, shall commence on or before **WEDNESDAY, FEBRUARY 10, 2021**, and Contractor shall complete the WORK within **ONE HUNDRED FIFTY(150), consecutive calendar days thereafter.** This Agreement, together with other documents enumerated in this ARTICLE 3, which said other documents are as fully a part of the Contract as if hereto attached or herein repeated, forms the Contract between the parties hereto. In the event

that any provision in any component part of this Contract conflicts with any provision of any other component part, the provision of the component part first enumerated in this ARTICLE 3 shall govern, except as otherwise specifically stated.


