**ORDER ADOPTING A MANDATORY PAYMENT FOR FISCAL YEAR 2021**

**WHEREAS**, pursuant to Section 288.201 of the Texas Health and Safety Code, the commission of a health care funding district may require an annual mandatory payment to be assessed quarterly on the net patient revenue of paying hospitals located in the district.

**WHEREAS**, pursuant to Section 288.102 of the Texas Health and Safety Code, the commission of a county health care funding district may require such mandatory payment with an affirmative vote of a majority of the members of the commission.

**WHEREAS**, the Commission of the Webb County Health Care Funding District having had a public hearing on Monday, June 14, 2021 regarding the proposed amount of the mandatory payment required of paying hospitals for fiscal year 2021 and how the revenue derived from those payments is to be spent;


**WHEREAS**, the Commission of the Webb County Health Care Funding District now desires to require a mandatory payment of 6.00% for fiscal year 2021 in order to generate revenue to provide the nonfederal share of a Medicaid supplemental payment program;


**IT IS HEREBY ORDERED** by the Commission of the Webb County Health Care Funding District that each paying hospital located in the Webb County Health Care Funding District pay a mandatory payment of 6.00% of its net patient revenue as determined by the data reported to the Department of State Health Services in the fiscal year ending in 2019 be adopted.


**FURTHER**, that the amount of the mandatory payment as set forth by this Order shall be effective upon adoption by the Commission.




