Adopting the Ad-Valorem Property Tax Rate For 2021

WHEREAS, on the 23rd day of August, 2021, the Commissioner's Court of Webb County, Texas convened in regular session of said Court; and

WHEREAS, Texas Tax Code §26.05 provides that the Webb County Commissioners Court shall adopt the tax rates for the current year; and

WHEREAS, the Commissioners Court finds that the tax levy is necessary for operations and maintenance purposes of the County as permitted by the Texas Constitution; and

WHEREAS, it is necessary to levy ad valorem taxes on each \$100 valuation of all taxable property in Webb County, Texas for the Tax Year beginning January 1, 2021 at the tax rates set forth hereinbelow; and

WHEREAS, in compliance with Tax Code §26.05, the following notice is hereby provided:

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY FIVE AND THIRTY-SEVEN HUNDRETHS (5.37) PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY (\$14.77).

WHEREAS, the Webb County Commissioners Court has complied with all statutory requirements as set forth in Texas Tax Code.

NOW THEREFORE, IT IS ORDERED by the Webb County Commissioners Court of Webb County that, after a public hearing and unanimous vote made during the Webb County Commissioners Court's regularly scheduled meeting, the following TAX RATE is hereby adopted and set:
