**A RESOLUTION AND ORDER OF THE WEBB COUNTY COMMISSIONERS COURT, AUTHORIZING THE FILING OF A COMMUNITY ~~OUTDOOR~~ OUTREACH PROGRAM GRANT APPLICATION WITH THE TEXAS PARKS AND WILDLIFE DEPARTMENT AND DESIGNATING THE COUNTY JUDGE AS THE AUTHORIZED REPRESENTATIVE OF THE COUNTY TO ACT ON BEHALF OF THE WEBB COUNTY COMMISSIONERS COURT IN ALL MATTERS PERTAINING TO THE SUBMISSION AND EXECUTION OF THE GRANT**

WHEREAS, the County of Webb is committed towards the betterment of the lives of its residents, particularly its ever-growing colonia and rural communities;

WHEREAS, the County of Webb recognizes its obligation to bring the simple but essential amenities of life to its residents, the majority of which belong to those groups typically classified as non-traditional constituencies, including minorities, youths, rural residents, women and persons with physical or mental disabilities;

WHEREAS, the County of Webb finds that the activities eligible under the Texas Parks & Wildlife Community Outdoor Outreach Program would serve to enrich the lives of urban and rural area youth;

WHEREAS, the County of Webb acknowledges the program implementation date cannot begin until funding is approved on or around March 1, 2022 and must be completed within the 18 month grant agreement period.

WHEREAS, the County of Webb seeks to provide meaningful educational outdoor recreational opportunities for the youth of its population; and,

WHEREAS, it is necessary and in the best interest of the County of Webb to avail itself of the Texas Parks and Wildlife Department's Community Outdoor Outreach Program;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONER'S COURT OF THE COUNTY OF WEBB, TEXAS:

1. That the County of Webb undertake a program to prepare outreach efforts in Webb County with the following criteria:

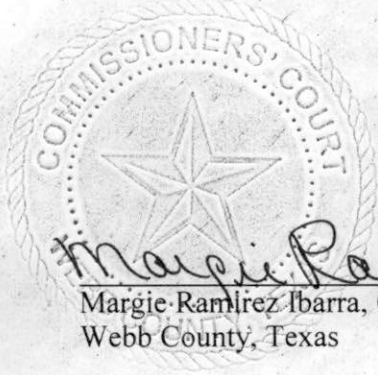
a) Identify all target areas that could best be served by the Community Outdoor Outreach Program.

b) Develop an educational program that would provide meaningful recreational opportunities to serve non-traditional constituencies who have been under represented in Texas Parks and Wildlife activities and programs, including minorities, youth, low income participants, rural residents, women, and persons with physical or mental disabilities.

2. That the requested amount of Community Outdoor Outreach Program funds not exceed \$60,000.00, with no match required.

3. That the Commissioner's Court directs and designates the County Judge as the County's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the County's participation in the Community Outreach Program.
