

The attached invoice is broken down to cover hardware for **1,969.00** which includes the diagnostics, keypad overlays, speakers, key drives, locks, diagnostic fees, support, reprogramming, firmware upgrades, labor costs, and return shipping by ground, etc.; and also, the MT Pro Standard EULA covers all client copies, upgrades and support for **\$995.00**. This support includes all upgrades free of charge, and required fixes to the program necessitated by Microsoft, in order to maintain the quality and operation of the proprietary MT Pro Standard Software. MTI is not responsible for loss of data. **Customer must maintain backups to enable MTI to assist in data recovery. Before changes are made to existing computers, customer must contact MTI for assistance.** Any hardware not listed under "Hardware Warranty Includes" is not covered. Site visits and additional training costs are not covered by this agreement and must be arranged for separately between **Webb County Road & Bridge and MTI**.

It is mandatory that **Webb County Road & Bridge** have a trained operator in the operation of the MegaTrak® System to keep it running properly. MTI must be notified should the fleet operator change as new training is required to insure the proper functioning of the MT System. **Please call MTI for a quotation and to make an appointment for support when upgrading software, working with third party software, or when adding, replacing, or relocating computers. This support is subject to a charge up to \$95.00.**


