EXHIBIT A

Despite the lack of block-level population data being available, utilizing voting precinct level populations that were acquired from the state's redistricting data, the existing County Commissioner Precincts (Pct) could be analyzed (see Exhibit B for population details at the VTD-level). The following is the result of that analysis.

The last two decennial censuses have resulted in Precincts 2 and 3 having the greatest population increases and Precinct 4 with the least. As a result, it may be advisable to attempt to keep Precincts 2 and 3 at or below the ideal population so that future potential impacts can be minimized.
