Project: FLOWatch 3.0 Professional Services for SWMOR Review

Scope of Work:

FLOWatch is currently in use to store operational and compliance information on Rio Bravo Water Treatment Plant. This plant is a surface water system and is required to furnish Surface Water Monthly Operating Report (SWMOR) each month. FLOWatch and TraCntrol developed the SWMOR feeds to furnish the report using the SWMOR-Alt format as required by TCEQ. 15-minute UV, Turbidities and Chlorine Residual data is transmitted each day to FLOWatch. Additionally, operators enter all manual data including flows, water quality, distribution sampling data, and UV weekly and monthly data. This information is presented to operators as a SWMOR Detail Report, from which data can be copied and pasted to SWMOR workbook report. The macros in the SWMOR workbook report automatically calculate the rest of the report, and ready the report for submission.

Because this process is data driven, FLOWatch Professional Services Support can be used each month to review the data, and alert operators, if there is a gap in data collection. Such a gap can exist for various reasons including but not limited to VTSCADA software, data transmission failure between VTSCADA and FLOWatch, missing operational data, fat-fingered operational data, etc. FLOWatch Professional Services Support include the following tasks:

1. Verify operational data daily through review of ad-hoc reports and charts.
2. Generate and review SWMOR Detail Report for data correctness.
3. Review and analyze SWMOR data trends, verify data conforms to normal ranges.
4. Review and analyze SWMOR Missing Data.
5. Review with operators to remediate any anomalous findings.

Exclusions and Assumptions:

Out-of-scope items include:

6. Copy-Paste SWMOR Detail data to the SWMOR workbook.
7. Review SWMOR Workbook for correctness.
8. Submission of SMWOR Workbook printouts to TCEQ in a timely manner.
9. VTSCADA and Historian Output related outage.

Terms:
