A RESOLUTION OF THE COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS, AUTHORIZING THE SUBMISSION OF A CONTRACT AMENDMENT REQUEST FOR THE TEXAS COMMUNITY DEVEPOPMENT PROGRAM'S (TCDP) CONTRACT BETWEEN WEBB COUNTY COMMUNITY ACTION AGENCY (CAA) AND TEXAS DEPARTMENT OF HOUSING & COMMUNITY AFFAIRS (TDHCA) OFFICE OF COLONIA INITIATIVES (OCI), CONTRACT NUMBER 7220013 (Self-Help Center Program).

WHEREAS, the County of Webb entered into a contract with the State of Texas to perform certain project activities; and

WHEREAS, unforeseen extenuating circumstances have changed projected goals and activities; and

WHEREAS, it is in the best interest of the County of Webb to submit a Contract Amendment to the Texas Community Development Program, Texas Department of Housing & Community Affairs (TDHCA), Office of Colonia Initiatives (OCI) to complete such activities.

NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS THAT:

The Webb County Commissioner's Court authorizes a contract amendment request to be submitted to the Texas Department of Housing and Community Affairs Program for the following proposed activities:

- 1. To increase the number of reconstruction homes from three (3) to four (4).
- 2. To increase the number of beneficiaries under the housing reconstruction activity from six (6) to eight (8).
- 3. To increase the maximum allowed cost per home from \$75,000 to \$100,000 under the new Reconstruction activity.
- 4. To increase the maximum allowed cost per home from \$75,000 to \$100,000 under the New Construction activity.
- 5. To increase the maximum allowed cost per home from \$60,000 to \$75,000 under the Rehabilitation activity.

The Webb County Commissioner's Court directs and authorizes the Webb County Judge to execute all necessary documents as may be required to initiate and process this contract amendment request.
