



- Average Wait Time for First Time visit / Consultation 20 minutes
- Average Wait Time for repeat consultations 10 minutes
- Use of Risk Management Staff offers the integration of Innovative Preventive Programs for Diabetes, Hypertension, and Hyperlipidemias. Staff thus becomes the integrative software to bridge insurance and accessible health care to employees and their dependents.

250 Employee Patients have been seen at the Webb County Medical and Wellness Center.

Approximate Financial Impact on Health Claims is \$62,500.00

- Programs in Development
- Purchase of Laboratory Equipment to test for Cholesterol, Hemoglobin A1C,
 Triglicerides, High and Low Density
 Lipoproteins, Glucose, with integrated testing for Covid, Respiratory Syncitial Virus, Flu Type I and II, and Streptococcus.
- Additional Module Added to serve as a laboratory. Power, water, boiler activated with a review of an evaporative cooler with fans to be evaluated. Module is located adjacent to current clinic location.
- Reviewing with Purchasing and Civil Legal the incorporation of Dietician Consulting services on a as needed basis for integration into our Wellness Program and AETNA Programs.

Purchase versus Lease options are being considered with a focus on need and use for employee population.

Full Report on Cost Proposals to be presented to Court.

- Development of Preventive Screenings Protocol working in tandem with Health Care Providers.
- Standardization of available glucometer test kits, lancets, test strips, lancing devices with education classes to all diabetic employee/patients. This will work in tandem with access to the dietician that will customize and monitor diet progress on individual participating employee/patients.

Development of follow-up protocol

All employee/patients seeking services for diabetes, hyoertension, and hyperlipidemias will be enjoined on a follow-up calendar protocol for continuous monitoring and adjustment of treatment.
