My name is Luis Perez Garcia III, and I reside in Laredo, Webb County, Texas. I am the Webb County Engineer and one of my duties is to oversee, supervise and direct the Right-of-Way Department's. staff, to acquire right-of-way, drainage and/or utility easements on behalf of Webb County and the Webb County Road and Bridge Department. Thave been employed as the Webb County Engineer since 2013.

It has come to my attention that due to a typographical error, simple mistake, human error and/or oversight, two (2) or more surveys with metes and bounds descriptions and tract numbers that are actually located in the Antonio Santos Subdivision, incorrectly state that they are located in the Antonio Sanchez Subdivision.

My staff and Thave been unable to locate the original Texas Registered Professional Land.
