AUTHORIZING THE SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT OF BLOCK GRANT PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF AGRICULTURE FOR THE COLONIA FUND – CONSTRUTION AND AUTHORIZING THE COUNTY JUDGE TO ACT AS THE COUNTY SEXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT

WHEREAS, the Commissioners Court of Webb County desires to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to-moderate income; and

PROGRAM.

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interests of Webb County to apply for funding under the Texas Community Development Block Grant Program;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS:

- 1. That a Texas Community Development Block Grant Program application for the Colonia Fund- Construction is hereby authorized to be filed on behalf of the County with the Texas Department of Agriculture.
- 2. That the County's application be placed in competition for funding under the Colonia Fund-Construction.
- 3. That the application be for up to \$1,000,000.00 of grant funds to provide Housing Rehabilitation.
- 4. That the Commissioners Court directs and designates the following to act in all matters in connection with this application and the County's participation in the Texas Community Development Block Grant Program:
 - The County Judge shall serve as the County's Chief Executive Officer and Authorized Representative to execute this application and any subsequent contractual documents;
 - The County Judge, County Commissioner for Precinct 1, County Commissioner for Precinct 2, County Commissioner for Precinct 3 and County Commissioner for Precinct 4 is authorized to execute environmental review documents between the Texas Department of Agriculture and the County; and

- If this application is funded, the County Judge County Commissioner for Precinct 1, County Commissioner for Precinct 2, County Commissioner for Precinct 3 and County Commissioner for Precinct 4 is authorized to execute the Request for Payment Form documents and/or other forms required for requesting funds to reimburse project costs.
- 5. That all funds will be used in accordance with all applicable federal, state, local and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.
- 6. That it further be stated that Webb County is not committing any cash contribution toward the administration activities of this housing rehabilitation project.
