Tilden Capital Operating, LLC, referred to as "Lessee," whose address is 3100 W. 7th, Suite 240, Fort Worth, Texas 76107, is the present owner of all rights, title, and interests under the Oil and Gas Lease, effective May 1, 2022, (the "Lease"), executed by **Webb County**, as agent for the State of Texas, "Lessor", recorded as Instrument Number 1470402, in Volume 5290 at Page 822, of the Official Public Records of Webb County, Texas, covering certain lands situated in that County and State, as more particularly described in the Lease. Reference is made to the Lease and to its recording for all purposes.

The Lessor and Lessee desire to amend the Lease to fix a clerical error in Section 2 in which the Leased Premises were inaccurately described.

For adequate consideration, Lessor hereby agrees to amend Section 2, Leased Premises to:

"10.0 acres of land, more or less, being a part of subdivision C-14, containing 20 acres, of the Botines Subdivision, Survey 744, A-2692, Webb County, Texas as per plat of said subdivision recorded in Volume 2, Page 212, Webb County Plat Records, and being further described in Warranty Deed dated April 3, 1972, from E.J. Dryden Jr. to Wenceslao Trevino Jr. recorded in Volume 418, Page 305, Deed Records, Webb County, Texas, SAVE AND EXCEPT: 10 acres of land, more or less, being described as C-14 "B" in Warranty Deed with Vendor's Lien dated March 10, 1980, from Wenceslao Trevino, Jr. et ux to Nancy Valle, et al, recorded in Volume 609, Page 282, Official Public Records, Webb County, Texas."


Lessor, hereby adopts, ratifies, and confirms the Lease as the same is amended, and grants, leases, and lets all of the land described above to Lessee, subject to and under the terms and provisions of the Lease. The Lease, as amended, is expressly affirmed, ratified, and declared to be effective and binding for all purposes as of the date this Amendment to Oil and Gas Lease is signed by Lessor.

The provisions of this instrument shall extend to and be binding on the heirs, successors, legal representatives and assigns of the Lessor and Lessee.





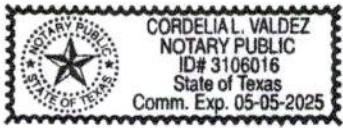
