RESOLUTION NO. 09-12-22-9A

A RESOLUTION OF THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS, AUTHORIZING THE SUBMISSION OF AN EMERGENCY COMMUNITY WATER ASSISTANCE GRANT APPLICATION TO THE US DEPARTMENT OF AGRICULTURE – RURAL DEVELOPMENT AUTHORIZING THE COUNTY JUDGE TO ACT AS THE COUNTY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE EMERGENCY COMMUNITY WATER ASSISTANCE GRANT

WHEREAS, the Commissioners Court of Webb County desires to develop a viable community, including safe and reliable drinking water, principally for persons of low-to-moderate income; and

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interests of Webb County to apply for funding under the Emergency Community Water Assistance Grant;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS:

1. That an Emergency Community Water Assistance Grant Program application is hereby authorized to be filed on behalf of the County with the US Department of Agriculture.
2. That the County's application be placed in competition for funding under the Emergency Community Water Assistance Grant.
3. That the application be for up to \$1,000,000.00 of grant funds to provide safe and reliable drinking water.
4. That the Commissioners Court directs and designates the following to act in all matters in connection with this application and the County's participation in the Emergency Community Water Assistance Grant Program
 - The County Judge shall serve as the County's Chief Executive Officer and Authorized Representative to execute this application and any subsequent contractual documents;
 - The County Judge, County Commissioner for Precinct 1, County Commissioner for Precinct 2, County Commissioner for Precinct 3 and County Commissioner for Precinct 4 is authorized to execute environmental review documents between the US Department of Agriculture and the County; and
 - If this application is funded, the County Judge County Commissioner for Precinct 1, County Commissioner for Precinct 2, County Commissioner for Precinct 3 and County


Commissioner for Precinct 4 is authorized to execute the Request for Payment Form documents and/or other forms required for requesting funds to reimburse costs.

5. That all funds will be used in accordance with all applicable federal, state, local and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.

6. That it further be stated that Webb County is not committing any cash contribution toward the administration activities of this project.



7. Webb County Economic Development Department is authorized to administer the application and grant if funded.


