



AMENDMENT TO SERVICES OPERATIONS CONTRACT

This document amends the Agreement by and between Webb County, Texas a political subdivision of the State of Texas for its Pre-Trial Services department (hereinafter "Department") and Recovery Monitoring Solutions (hereinafter "Agency") to provide Global Positioning System (GPS) Monitoring, Radio Frequency (RF) Monitoring, Continuous Alcohol Monitoring, Breath-Alcohol Testing, and Drug Patch Testing services for the Department.

Whereas, the parties have determined that provisions of their existing agreement need to be revised in order to accurately reflect the agreement between the parties.

Now therefore, the parties hereby agree to amend the existing Agreement as follows:

1. Modification of Term Section:

This AGREEMENT shall become effective for a one (1) year period beginning on October 1, 2022 and ending on September 30, 2023 (unless terminated herein under the provisions below). The agreement shall may be renewed for another one-year term, unless either party provides notice to the other of its intent to terminate the agreement not less than thirty (30) days before the end of the then current term.

2. Recovery Monitoring Solutions and the Department agree to the following rates for the GPS Monitoring Program:

Department Funded

Active \$8.00

Passive \$6.00

Participant Funded:

Active \$9.00

Passive \$8.00

3. Recovery Monitoring Solutions and the Department agree to the following rates for the Drug Patch

Program: Department Funded: \$75.00 Participant Funded: \$80.00

Please Note: This unavoidable rise in price is the direct result of increased costs levied on Recovery Monitoring Solutions by the equipment manufacturer. Please understand that the application of this elevated rate only serves to maintain – not enhance – our current profit margin.

4. All other terms and conditions not explicitly revised by this amendment remain in effect.
