

Resolution

Resolution of THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS authorizing the filing of a grant application with the SOUTH TEXAS DEVELOPMENT COUNTY FY 2023 for a regional solid waste grants program grant; authorizing THE COUNTY JUDGE to act on behalf of WEBB COUNTY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE in all matters related to the application; and pledging that if a grant is received WEBB COUNTY will comply with the grant requirements of the SOUTH TEXAS DEVELOPMENT COUNCIL and the Texas Commission On Environmental Quality and the State of Texas.


Whereas, the SOUTH TEXAS DEVELOPMENT COUNCIL is directed by the Texas Commission on Environmental Quality to administer solid waste grant funds for implementation of the Council of Government (COG's) adopted regional solid waste management plan; and

Whereas, WEBB COUNTY in the State of Texas is qualified to apply for grant funds under the Request for Applications.

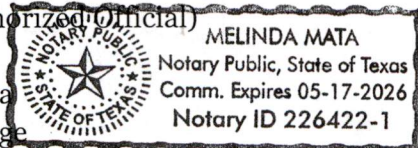
Now, therefore, be it resolved by THE COMMISSIONER'S IN WEBB COUNTY, Texas;

1. That Hon. Tano Tijerina, Webb County Judge is authorized to request grant funding under the South Texas Development Council Request for Applications of the Regional Solid Waste Grants Program and act on behalf of WEBB COUNTY in all matters related to the grant application and any subsequent grant contract and grant project that may result.
2. That if the project is funded, WEBB COUNTY will comply with the grant requirements of the SOUTH TEXAS DEVELOPMENT COUNCIL, Texas Commission on Environmental Quality and the State of Texas.
3. The grant funds and any grant-funded equipment or facilities will be used only for the purposes for which they are intended under the grant.
4. Activities will comply with and support the adopted regional and local solid waste management plans adopted for the geographical area in which the activities are performed.




