

RESOLUTION

A RESOLUTION OF THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS, AUTHORIZING PARTNERING WITH ZAPATA COUNTY IN ITS SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF AGRICULTURE FOR THE COLONIA FUND PLANNING AND NEEDS ASSESSMENT PROGRAM.

WHEREAS, the Commissioners Court of WEBB County desires to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to moderate-income;


WHEREAS, the activities of the Colonia Fund: Planning & Needs Assessment Program will significantly benefit residents of WEBB County; and

WHEREAS, it is necessary and in the best interests of WEBB County to partner with ZAPATA County in its application for funding under the Colonia Fund Planning and Needs Assessment Program of the Texas Community Development Block Grant Program;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONER'S COURT OF WEBB COUNTY, TEXAS:


1. That ZAPATA County is authorized to include the colonia communities of WEBB County in its Texas Community Development Block Grant Program application with the Texas Department of Agriculture for the Colonia Fund: Planning & Needs Assessment Program.
2. That ZAPATA County is authorized to act as WEBB County's agent for the purpose of the receipt of funds for the Colonia Fund Planning and Needs Assessment Program and contracting with and managing the contract with a third-party service provider to conduct the Colonia Fund Planning and Needs Assessment.
3. That ZAPATA County and its duly authorized third-party service provider may have access to WEBB County records reasonably necessary to conduct the Colonia Fund Planning and Needs Assessment, to the extent allowed and provided for under applicable law.
4. That the Commissioners Court directs and designates the (County Judge, Tano Tijerina AND Commissioner of Precinct 2 Rosaura Tijerina to act in all matters in connection with this application and the County's participation in the Texas Community Development Block Grant Program.


