A RESOLUTION OF THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS, AUTHORIZING THE SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF AGRICULTURE FOR THE COMMUNITY DEVELOPMENT FUND; AND AUTHORIZING THE WEBB COUNTY JUDGE TO ACT AS THE COUNTY'S EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM; AND AUTHORIZING THE COUNTY JUDGE TO EXECUTE ANY AND ALL RELEVANT DOCUMENTS AND ANY OTHER MATTERS INCIDENT THERETO.

WHEREAS, the Commissioners Court of Webb County desires to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low-to-moderate income; and

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interests of Webb County to apply for funding under the Texas Community Development Block Grant Program;

WHEREAS, the Commissioners Court of Webb County is committed compliance with federal, state, and program rules, including the current Tx-CDBG Project Implementation Manual; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS:

1. That a Texas Community Development Block Grant Program application for the Community Development Fund is hereby authorized to be filed on behalf of the County with the Texas Department of Agriculture.
2. That the County's application be placed in competition for funding under the Community Development Fund.
3. That the application be for \$500,000.00 of grant funds to provide street improvements.
4. That it further be stated that the County of Webb is committing \$75,000.00 from its general fund as a cash contribution toward the administration activities of this first-time paving project.
5. That the Commissioner's Court directs and designates the following to act in all matters in connection with any grant application and the County's participation in the Texas Community Development Block Grant Program:
6. The Webb County Judge shall serve as the County's Chief Executive Officer and Authorized Representative to execute this grant application and any subsequent contractual documents,

7. The Webb County Judge, County Commissioner for Precinct 4 and County Commissioner for Precinct 2 as authorized to execute environmental review documents between the Texas Department of Agriculture and Webb County, and

8. If this application is funded, the Webb County Judge, County Commissioner for Precinct 4 and County Commissioner for Precinct 2 as authorized to execute the Request for Payment form documents and/or other forms required for requesting funds to reimburse project costs, and

9. The Webb County Judge, County Commissioner for Precinct 4 and County Commissioner for Precinct 2 be assigned the role of Authorized Official in the TDA-GO grant management system.


10. In addition to the above designated officials, should any grant be funded the Economic Development Director, County Clerk, County Auditor, and County Treasurer is authorized to certify the Payment Request form and/or other forms required for requesting funds to reimburse project costs, prepare and submit other financial documentation, and be assigned the role of Project Director or Payment Processor in the TDA-GO grant management system.

11. That all funds will be used in accordance with all applicable federal, state, local, and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.




