A RESOLUTION OF THE COMMISSIONER'S COURT OF THE COUNTY OF WEBB AUTHORIZING THE SUBMISSION OF A GRANT PROPOSAL TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS OFFICE OF COLONIA INITIATIVES FOR THE SELF-HELP CENTER GRANT PROGRAM.

WHEREAS, IT IS NECESSARY AND IN THE BEST INTEREST OF WEBB COUNTY TO SUBMIT A GRANT PROPOSAL FOR THE SELF-HELP CENTER PROGRAM AND TO APPOINT THE COUNTY JUDGE AS THE AUTHORIZED SIGNATOR FOR ALL RELEVANT CONTRACT DOCUMENTS.


NOW THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSIONER'S COURT OF THE COUNTY OF WEBB, TEXAS:


1. The County Commissioner's Court authorizes the Community Action Agency to submit a grant proposal to the Texas Department of Housing and Community Affairs, Office of Colonia Initiatives for Self-Help Center Program funding in an amount not to exceed \$800,000;
2. The Commissioner's Court appoints the Webb County Judge as the authorized signatory for all relevant contract documents;





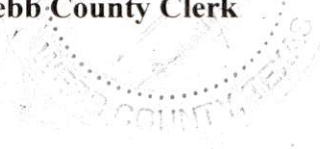
