RESOLUTION AND ORDER

A RESOLUTION AND ORDER OF THE COMMISSIONERS COURT OF WEBB COUNTY, TEXAS FOR AUTHORIZATION TO ENTER INTO AN ADVANCE FUNDING AGREEMENT WITH THE STATE OF TEXAS, TEXAS DEPARTMENT OF TRANSPORTATION REGARDING THE TRANSPORTATION SET ASIDE (“TA”) PROGRAM FOR SIDEWALK IMPROVEMENTS IN THE CITY OF RIO BRAVO TEXAS

WHEREAS, The Texas Department of Transportation issued a call for projects in December 2022 for communities to apply for funding assistance through the “Transportation Alternative Set-Aside (TA) Program” for the construction of pedestrian and/or bicycle infrastructure; and

WHEREAS, the Webb County Commissioners Court., at a commissioners court meeting of January 23, 2023, authorized, through a Resolution, the submission of an application, to the State of Texas, Texas Department of Transportation, for the “Transportation Alternative Set-Aside (TA) Program for the construction of pedestrian and/or bicycle infrastructure on behalf of the cities of Rio Bravo and El Cenizo, as well the census designated place of Bruni, Texas; and

WHEREAS, the State of Texas, through the Texas Department of Transportation, approved the application but only to fund the construction of new pedestrian sidewalks in the City of Rio Bravo of approximately Four Thousand Four Hundred Eighty-Five (4,485) linear feet of new sidewalks from Salvador Garcia Middle School (Peña Drive) to the Rio Bravo Community Center (including Orquidia and Limon Street).

NOW THEREFORE BE IT RESOLVED AND ORDERED BY THE COMMISSIONER’S COURT OF WEBB COUNTY


That the County of Webb is hereby authorized to enter into an Advance Funding Agreement with the State of Texas for the construction of Webb County Rio Bravo Sidewalks Improvements from Jose Avenue to Orquidia Lane, Rio Bravo, Texas for a total estimated cost of One Million One Hundred Eighty Thousand Fifty-Nine Dollars (\$1,180,059.00), with the County receiving Transportation Development credits of Two Hundred Thirty-Six Thousand Twelve Dollars (\$236,012.00), and authorize the County Judge to execute all documents necessary to complete this transaction.

That it is hereby officially found and determined that the meeting at which this Resolution and Order was passed was open to the public and that public notice of the time, place and purpose of said meeting was given as required by law.
