

AGREEMENT BETWEEN WEBB COUNTY AND KOFI TECHNOLOGIES, INC. FOR THE PRESERVATION OF CASE FILES (Project 21)

The original Agreement, dated March 27, 2023 by and between **WEBB COUNTY**, a political subdivision of the State of Texas (hereinafter called "County") for the benefit of the Webb County District Clerks Office and Kofile Technologies, Inc. (hereinafter called "Kofile."), is hereby amended as set forth below:

Paragraph 1: The original agreement contained an estimate in which ARPA funds would be utilized to pay for the project. Said estimate exceeded the allocated ARPA funds. The Webb County District Clerk has the authority and funds to pay the remaining balance from the Account # 2034-2290-001-460105 which is from the discretionary funds utilized by the District Clerks to preserve documents.

Paragraph 2: The parties agree that the foregoing amendment shall be hereinafter considered a part of the contract referred to above and incorporated by reference therein for all purposes. The amendments shall be subject to any and all other provisions of the contract which are hereby ratified by the parties and remain in full force and effect, with the exception of the parts or provisions of the contract which have been modified by this amendment or prior amendments.

Paragraph 3: The parties agree that the foregoing amendment requires additional consideration for services not contemplated at the time of the original agreement. The additional funding shall run with the original agreement attached hereto in the amount not to exceed \$29, 232.41 for FY 2023-2024

This Agreement becomes effective when signed by the last party whose signing makes the Agreement fully executed.


