Does not include after-hour, weekend or holiday service, service or parts due to accidents, fire, water, storm negligence or misuse, power failures, current fluctuations, lightning, Daylight Savings Time changes, or for any cause external to the equipment. Specification changes, alterations, or attachments may require a change in maintenance charges. When, in the technician’s opinion, parts/service cannot keep the unit in satisfactory operating condition, an estimate will be submitted. Such work, if authorized by the customer, will be in addition to the maintenance charge. Renewals starting in 2024, Rapidprint stamps with serial number 350000 and lower and Widmer stamps with serial number 190000 and lower will no longer be covered under a PMA. GTR can continue to service these machines, but they will be subject to our current hourly rate of \$125 per hour, not including parts, shipping or travel costs.


