**RESOLUTION 06-10-2024-21
WEBB COUNTY COMMISSIONERS COURT
WEBB COUNTY, TEXAS**

AUTORIZING THE COUNTY JUDGE TO ENTER INTO AN ADVANCE FUNDING AGREEMENT FOR BRIDGE REPLACEMENT OR REHABILITATION PROJECTS WHERE THE LOCAL GOVERNMENT MATCH CONTRIBUTION IS WAIVED FOR MANGANA HEIN RD. AT DOLORES CREEK (OFF THE STATE SYSTEM), NATIONAL BRIDGE INVENTORY (NBI) STRUCTURE NUMBER 222400AA0313004 STATE CONTROL-SECTION-JOB (CSJ) NUMBER 0922-33-235

WHEREAS, the federal off-system bridge program is administered by the Texas Department of Transportation (the State) to replace or rehabilitate structurally deficient and functionally obsolete (collectively referred to as deficient) bridges located on public roads and streets off the designated state highway system; and

WHEREAS, Webb County, hereinafter referred to as the Local Government owns bridges located at Mangana Hein Rd. at Dolores Creek, National Bridge Inventory (NBI) Structure Number 222400AA0313004 State Control-Section-Job (CSJ) Number 0922-33-235; and

WHEREAS, a project to remedy the bridge is included in the currently approved program of projects as authorized by Texas Transportation Commission Minute Order Number 116522. Dated August 16, 2023; and

WHEREAS, federally-eligible items of work for this project are approved for 100% federal and state funding through the Infrastructure Investment and Jobs Act (IIJA) as well as the Highway Bridge Replacement and Rehabilitation Program (HBRRP).

WHEREAS, the typical estimated local match fund participation requirement for federally-eligible items of work is waived in full for CSJ 0922-33-235.

WHEREAS, any non-eligible items of work will be paid by the Local Government; and

NOW, THEREFORE, BE IT RESOLVED BY THE WEBB COUNTY COMMISSIONERS COURT THAT:

Section 1: Webb County approves entering into an Advance Funding Agreement with the Texas Department of Transportation where the Local Government Match Contribution is Waived for Mangana Hein Rd. at Dolores Creek (OFF THE STATE SYSTEM), National Bridge Inventory (NBI) Structure Number 222400AA0313004 State Control-Section-Job (CSJ) NUMBER 0922-33-235
