

Amendment 1
To
Agreement Between Texas A&M International University
And
County of Webb

THIS AMENDMENT 1, dated June 21, 2024, is entered into and effective June 21, 2024, by and between **WEBB COUNTY**, a political subdivision of the State of Texas (hereinafter called "County of Webb") and the **TEXAS A&M UNIVERSITY SYSTEM** and an agency of the State of Texas ("TAMIU") and collectively referred to as "the Parties".

The original Agreement, dated July 21, 2023 by and between WEBB COUNTY, a political subdivision of the State of Texas (hereinafter called "County") and the TEXAS A&M UNIVERSITY SYSTEM (hereinafter called "TAMIU"), to produce a report to be titled " Structural and Administrative Analysis of Webb County, Texas 2000-2020 ", is hereby amended (with the bracketed strikethrough language no longer being in effect and the underscored italicized language being effective) as set forth in Paragraph 1 below:

Paragraph 1:

9. County of Webb shall cover expenses in an amount not to exceed Fifty Thousand Dollars (\$50,000.00) for Year 2 (~~August 1, 2024~~ June 21-2024-July 31, 2025).

Paragraph 2:

The parties agree that the foregoing amendment (with the bracketed strikethrough language no longer being in effect and the underscored italicized language being effective) shall be hereinafter considered a part of the Agreement referred to above and incorporated by reference therein for all purposes. The amendments shall be subject to any and all other provisions of the Agreement which are hereby ratified by the parties and remain in full force and effect, with the exception of the parts or provisions of the contract which have been modified by this amendment or prior amendments.

This Agreement becomes effective as set forth above irrespective of the date/dates signed.






