**RESOLUTION NO. 07-24-2023-33**

**WEBB COUNTY COMMISSIONER COURT**

**APPOINTMENT TO THE RIO GRANDE REGIONAL WATER AUTHORITY**

**WHEREAS**, Webb County is a duly created and validly existing political subdivision of the State of Texas under the Constitution and laws of the state of Texas and governed by the Webb County Commissioners Court; and,

**WHEREAS**, the Webb County Commissioners Court, the governing body of the county is charged with making appointments to various Authorities, Boards and Committees; and,

**WHEREAS**, legislation passed by the State of Texas reconstituted the composition of the Rio Grande Regional Water Authority by appropriating six (6) seats on the Rio Grande Regional Water Authority to be comprised of County representatives, thereby authorizing the Webb County Commissioners Court to appoint one (1) suitable candidate to serve on the Rio Grande Regional Water Authority, said appointee being subject to the approval of the Court of Commissioners and whose term shall run concurrent with the term of office of the nominating Commissioners district; and,

**RESOLVED**, the Commissioners Court hereby declares that the preamble and provisions set forth hereinabove constitute, and shall be considered to be, substantive provisions of this Resolution and are hereby incorporated by reference into this provision; and,

**BE IT FURTHER RESOLVED** that the Commissioners Court hereby does make the following appointment to the Rio Grande Regional Water Authority, to be effective immediately, having determined that the individuals meet all legal requirements to serve on said Rio Grande Regional Water Authority, and fixes their terms as outlined below:

The appointee shall be **Jorge A. Calderon, CFM**, whose term shall expire on December 31st, 2025, and who shall be eligible for reappointment to a full term of office should the Commissioners Court so desire.

**BE IT FURTHER RESOLVED** that future regularly required appointments to the Rio Grande Regional Water Authority shall be made at the first scheduled meeting of the Webb County Commissioners Court, in the year in which a seat is due for appointment or reappointment; and,

**BE IT FURTHER RESOLVED** that in the event an appointee so designated in this resolution should become unable or ineligible to continue to serve their term of appointment, that the Webb County Commissioners Court shall cause to be appointed a replacement that shall serve only until


the term of the original appointment has been completed, subject to reappointment if the Webb County Commissioners Court so desires; and,

**BE IT FURTHER RESOLVED** that the Webb County Commissioners Court reserves its right in any appointments now or in the future to not reappoint a sitting board member to any authority, board or committee for which it has appointment power, for any reason that it should choose or no reason at all; and,

**BE IT FINALLY RESOLVED** that the Webb County Commissioners Court authorizes the Honorable Tano E. Tijerina, Webb County Judge, to sign this Resolution on the Commissioners Court behalf and authorizes the County Clerk to attest all signatures and transmit this document to the appropriate entities of Webb County and the Rio Grande Regional Water Authority.
