

## RESOLUTION AUTHORIZING SIGNATORIES

**A RESOLUTION BY COMMISSIONER'S COURT OF THE COUNTY OF WEBB TEXAS, DESIGNATING AUTHORIZED SIGNATORIES FOR CONTRACTUAL DOCUMENTS AND DOCUMENTS FOR REQUESTING FUNDS PERTAINING TO THE TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (TxCDBG) CONTRACT NUMBER 713015.**

WHEREAS, the County of Webb, Texas has received a 2013 Texas Community Development Block Grant award to provide (Water/Wastewater) improvements, and;

WHEREAS, it is necessary to appoint persons to execute contractual documents and documents for requesting funds from the Texas Department of Agriculture, and;

WHEREAS, an original signed copy of the TxCDBG *Depository/Authorized Signatories Designation Form* is to be submitted with a copy of this resolution, and;

WHEREAS, the County of Webb, Texas acknowledges that in the event that an authorized signatory of the County changes (elections, illness, resignation, etc.), the County must provide TxCDBG with the following:

- A resolution stating who are the new authorized signatories (not required if this original resolution names only the title and not the name of the signatory); and
- A revised TxCDBG Depository/Authorized Signatories Designation Form.

**NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONER'S COURT OF THE COUNTY OF WEBB, TEXAS, AS FOLLOWS:**

The County Judge is hereby authorized to execute contractual documents between the Texas Department of Agriculture and the County for the 2013 Texas Community Development Block Grant Program.

The County Judge, County Commissioner, Pct. 1, County Commissioner, Pct. 2 are hereby authorized to execute the *State of Texas Purchase Voucher and Request for Payment Form* documents required for requesting funds approved in the 2013 Texas Community Development Block Grant Program.


